## PRESENTERS CONTINUED

**David Cummings DDS** earned his undergraduate degree at the University of California San Diego, dental degree and residency in oral and maxillofacial surgery at the USC School of Dentistry and a fellowship in reconstructive jaw surgery. He has been a Diplomate of the American Board of Oral and Maxillofacial surgery and has served on the Board of Examiners. Dr Cummings holds a faculty position as assistant clinical professor at the Herman Ostrow School of Dentistry of USC.

**Arthur Curley JD** is senior trial attorney in the San Francisco based health care defense firm of Bradley, Curley, Barrabee & Kowalski where he is president and managing partner. He received his BS from the University of California Berkeley and JD from UC Hastings College of the Law. He is Assistant Professor of Dental Jurisprudence at the Dugoni School of Dentistry in San Francisco and Faculty Lecturer in Jurisprudence at the University of California San Francisco.

**Joseph Kan DDS MS** completed specialty training in Prosthodontics and MS in Implant Surgery at Loma Linda University School of Dentistry where he is a Professor in the Department of Restorative Dentistry and research coordinator for the Implant Dentistry Program. He is trained in the surgical and restorative discipline of implant dentistry. Dr Kan lectures internationally and has published articles in reference journals and chapters in textbooks with emphasis on tissue management and anterior implant esthetics.

**Robert Lytle DDS** earned his Bachelor of Science and DDS degrees from the University of Southern California. He went on to Louisiana State University where he completed a general surgery internship and oral and maxillofacial surgery residency at Charity Hospital in New Orleans. He has served as chairman of the oral and maxillofacial surgery section at Huntington Hospital in Pasadena. He is past president of the Glendale Academy of Dentists. He is in private practice in Glendale, La Canada and Pasadena.

**Waldemar Polido DDS MS PhD** is a Clinical Professor and Acting Chair of the OMS Program at the Indiana University School of Dentistry. He is Co-Director of the Center for Implant, Esthetic and Innovative Dentistry at IUSD. He received his DDS, master's and doctoral degrees in OMS from the PUCRS School of Dentistry in Brazil. He completed an OMS residency at the University of Texas Southwestern Medical Center. Dr Polido specializes in digital planning tools for implant dentistry and orthognathic surgery.

**Roberta Ashley CRNA EdD CHSE** is the only Advanced Trauma Life Support certified CRNA at LAC/USC Medical Center. She is OMS Anesthesiology Education Director and Assistant Professor of Clinical Anesthesiology at Keck School of Medicine of USC. She supervises OMS Resident Anesthesiology Education at the Ostrow School of Dentistry of USC and Harbor-UCLA Medical Center. Dr Ashley received her Doctor of Educational Psychology and Certified Healthcare Simulation Educator.

**Bach Le DDS MD** completed his specialty training in Oral & Maxillofacial Surgery at Oregon Health Sciences University. He is Clinical Associate Professor of Oral & Maxillofacial Surgery at the Herman Ostrow School of Dentistry of USC where he has been an active faculty member since 2000. Dr Le has lectured internationally on bone regeneration and dental implant-related surgery and has taught on six continents. **David Gilbert DDS MS MBA** received his DDS at Loma Linda University School of Dentistry, MS at LLU Graduate School, MBA at the University of Redlands School of Business and residency in oral and maxillofacial surgery at LLU Medical Center. ### SESSION I

**WALDEMAR POLIDO DDS MS PhD**

#### **DIGITAL WORKFLOW FOR IMPLANT PLANNING AND SURGERY**

Program Abstract: More than ever before digital processes are used in treatment planning for implant surgery and restorations. The multiple technologies of 3D cone beam CT imaging, intraoral scanning, laboratory scanning, 3D digital restorative design and CAM production have contributed to this trend. When digitally planning a guided implant surgery, there are many clinical aspects to be considered, aside from the digital planning and the guided procedure per se. Soft tissue thickness and biotype, with or without a flap, need for graft, size and type of graft, choice of implant, primary stability and the possibility of immediate loading are just a few aspects that need to be considered when planning an implant surgery, being it in a conventional or digital manner. The novelty and attention that the digital planning and guided surgery bring to the Implant Dentistry scenario cannot lead us as clinicians to overlook important aspects that will influence the final outcome and the long-term stability of the result.

### SESSION II

#### **TOOTH REPLACEMENT IN THE ESTHETIC ZONE: LESSONS LEARNED FROM 24 YEARS**

Program Abstract: Achieving anterior implant esthetics with immediate implant placement can be a challenge. This evidence-based presentation will focus on current implant treatment philosophies and methodologies for failing maxillary tooth in the esthetic zone. Emphasis will be placed on diagnosis and treatment planning and surgical and prosthetic management for implant esthetics. Long term follow-up will be presented.
